

8th International Workshop on Ultra-Wide Bandgap Materials and Devices

Conference rules and regulations

§1 General provisions

- These regulations define the rules for participating in the 8th International Workshop on Ultra-Wide Bandgap Materials and Devices 2025, hereinafter referred to as the Workshop.
- 2. The Workshop will be held on 21-24 September 2025 in building D20, located at the Wrocław University of Science and Technology (WUST), Janiszewskiego 8 Street, 50-372 Wrocław, Poland.
- 3. The Workshop is organized jointly by the Department of Experimental Physics, Wrocław University of Science and Technology, and Łukasiewicz Research Network PORT Polish Center for Technology Development, Wrocław, Poland.
- 4. The participant acknowledges that registering for the Workshop (section 2 below) is tantamount to accepting these Regulations.
- 5. The schedule and program of the Workshop are available at https://iwumd2025.pwr.edu.pl
- 6. The official language of the Workshop is English.
- 7. Each date is given in the local time (Central European Standard Time, GMT + 1).
- 8. The Organizer is eligible to change the program without providing reasons.
- 9. The Rules and Regulations are available on the official Workshop website.

§2 Rules for participation

- 1. A participant in the Workshop is every person who participates in it.
- 2. Participation in the Workshop is possible on the basis of prior registration.
- 3. Participation in activities requiring prior registration without prior registration is not possible subject to the resignation from participation by a registered Participant.
- 4. The participants accept the established rules for the course of the Workshop and its program and undertake not to influence its change and not to disturb the course of the Workshop.
- 5. The registration for Participants in the Workshop can be made only through the registration form available online on the official Workshop website: https://iwumd2025.pwr.edu.pl The deadline for submitting the applications is published on the webpage: https://iwumd2025.pwr.edu.pl

- 6. Completing registration into the Registration System shall be preceded by the Participant's acceptance of the Regulations.
- 7. In the event of resignation from participation in the Workshop, the Participant is obliged to immediately inform the Organizer by sending relevant information to the email address: iwumd2025@pwr.edu.pl

The Organizer is not responsible for any incorrect or untrue data provided by the Participant, when registering for the participation in the Workshop.

- 8. Department of Experimental Physics, Wrocław University of Science and Technology, and Łukasiewicz Research Network – PORT, as co-organizers of the Workshop, plan to conduct a photo report of the Workshop for documentation (e.g. reports), information (available on the Workshop website, and other websites of WUST, and PORT with information about the Workshop and their course), promotional (e.g. websites of WUST, profiles of PORT in social media) and archiving (in the field of recordings and photo coverage).
- 9. By participating in the Workshop, the Participant agrees to record and use his image for the purposes indicated in sec. 8 above, without the right to remuneration in this respect. The consent covers the dissemination by WUST and PORT of the image recorded in connection with participation in the Workshop by recording, reproducing using any techniques, disseminating, using, placing on the market, lending, public performance, inserting, displaying, reproducing, broadcasting, public sharing, archiving, in particular on the websites of WUST and PORT, on the profiles of WUST and PORT in social media, promotional events.
- 10. Participation in the Workshop requires a fee. To be able to participate in the Workshop, the Participants are required to fill in the registration form and pay the registration fee. The registration fee depends on the registration type and on time of the registration. Tables with prices are available on the official website and below. All registration fees are in EUR and include VAT. The bank account number is given below.

- 11. A 'Special Participant' is a designated registration category available under specific circumstances. or by online payment (credit card) which is available during a registration process.

The bank transfer costs are fully borne by the Participant.

- 13. Participation in the Workshop is only possible on-site.
- 14. Accompanying persons have the possibility to participate in the Workshop's accompanying events (Networking meeting) only upon registration via the form available on the Workshop website. The fee for this type of participation is 75 Euro and the payment is possible via bank transfer or by online payment (credit card), which is also mentioned in the registration system.
- 15. During the registration, the participant is requested to enter the following data into the registration form:
 - name and surname, title (optional), country, e-mail address, phone number, special requirements (if applicable),
 - data required for invoicing purposes,
 - consent for the processing of personal data by the Organizer in compliance with the enclosed declarations.
- 16. The completion of registration is confirmed by an e-mail sent to the mail address indicated in the form. The message also includes payment information. The registration is fully completed only if the payment is successful.

- 18. The registration fee includes:
 - Admission to the 8th International Workshop on Ultra-Wide Bandgap Materials and Devices;
 - Online information material;
 - Delegate badge. Only attendees who wear the personal badge will be able to attend the Workshop and let into the Workshop venue;
 - Lunches and coffee breaks;
 - Networking meeting on September 23rd, 19:00-23:00;
- 19. Early Bird registration is available only for attendees who fill in the registration form and proceed with the payment before 21st July 2025.
- 20. The Payer (recipient of the invoice) is the entity indicated by the Participant in the registration form.
- 21. By paying the fee the Participant authorizes the Organizer to issue a VAT invoice and send it only to the e-mail address provided in the registration form.
- 22. Cancellation of the Workshop fee is possible:
 - a) until 31.07.2025, 100% of the fee will be refunded minus a 50 EUR administrative fee;
 - b) after 31.07.2025, no fee refund.
- 23. Cancellation on dates later than those specified in items: 21a, 21b refunds will be at the discretion of the Organizing Committee.
- 24. No payment for participation in the Workshop on the date specified by the Organizer entitles the Organizer to cancel the participation application, without incurring any liability for damages.

- 25. In the registration form, there is a dedicated field (Comments / Special requirements) to specify any special requirement of the attendees.
- 26. Registration will begin on March 31, 2025.

§3 Abstract submission

- 1. Only the registered person can send an abstract via the abstract system indicated on the official Workshop website.
- 2. Please note that registration fees only allow two scientific paper presentations per participant.
- 3. All rules related to the form of abstracts are contained in the Workshop website under the 'Abstract Submissions' tab.

§ 4 Safety rules

- During the Workshop, it is forbidden to manifest one's worldview, including in particular political views. It is forbidden to conduct commercial, promotional and advertising activities during the Workshop, except for cases when a given entity has obtained a separate consent from the organizer of the Workshop.
- 2. The Organizer of the Workshop, in the event of disturbing public order by the Participant, is entitled to remove him from participation in the Workshop by blocking the possibility of participating to individual sessions of the Workshop. In order to ensure safety during the Workshop, the Workshop organizer may record the course of the Workshop.

§5 Personal data protection

1. Agreement clause:

I agree to the processing of my personal data included in the registration form for the purpose and scope necessary to organize the 8th International Workshop on Ultra-Wide Bandgap Materials and Devices held in Wrocław on 21-24 September, 2025, by Wrocław University of Science and Technology, Department of Experimental Physics, Wrocław, Poland, at Wybrzeże Stanisława Wyspiańskiego 27, 50-370 Wrocław, Poland

- 2. Information clause:
 - Your personal data will be processed in order to organize the 8th International Workshop on Ultra-Wide Bandgap Materials and Devices according to Art. 6 section 1 point a of the General Data Protection Regulation of April 27, 2016;
 - The recipients of your personal data will be: event Organizer
 - Your personal data will be kept for the period of preparation, implementation and evaluation of the 8th International Workshop on Ultra-Wide Bandgap Materials and Devices;
 - You have the right to access your data and the right to rectify, delete, limit processing, the right to data transfer, the right to object, the right to withdraw consent at any time without affecting the legality of processing, which was made on consent before its withdrawal;

- You have the right to file a complaint with the President of UODO when you feel that the processing of your personal data regarding you violates the provisions of the General Data Protection Regulation of 27 April 2016.
- 3. Your personal data will not be subject to automatic decision making or profiling
- 4. You have the right to lodge a complaint with the President of the Personal Data Protection Office if you believe that the processing of your personal data violates the provisions of the GDPR.

§6 Final Provisions

- 1. The Organizer is not responsible for Participants' belongings that have been lost, damaged or stolen during the Workshop.
- 2. Each Participant of the Workshop bears full financial liability for damage caused during the Workshop.
- 3. The Organizer is not liable for damage caused to the Participant as a consequence of force majeure. Force majeure is understood as an event or combination of events or circumstances, independent of the Organizer, which generally hamper or prevent the Organizer's obligations and which the Organizer could not have predicted or prevented or overcome by acting with due diligence.
- 4. The Organizer reserves the right to change the date or cancel the Workshop for reasons beyond their control. If the event of the Workshop being cancelled, the Organizer will refund the entire fee paid by the Participant to the bank account which was used to make a payment.
- 5. The Organizer does not cover the costs which are not mentioned in the Registration fees cover.
- 6. The Organizer has the exclusive right to a binding interpretation of the Regulations.
- 7. These Regulations shall enter into force upon acceptance.
- 8. The Workshop Participant, in accordance with Article 81 paragraph 1 of the Act of February 4, 1994 on copyright and related rights (Journal of Laws, 2019, item 1231 as amended) agrees to the free and noncommercial dissemination by the Organizer (or on the Organizer's behalf) of the Participant's image recorded in connection with the participation in the Workshop in any available form, including photography and film, without territorial or time restrictions, within the following fields of exploitation: copying, reproduction, dissemination, lending for use, and broadcasting, including via the Internet.

APPENDIX 1

The Regulations of charging by electronic means

Article 1

Definitions

For the purposes of these Regulations the following terms are defined as:

The Organizer - Wroclaw University of Science and Technology established by the National Council Decree of 24 August 1945, published in the Journal of Law of 1945 of 19 September 1945, having its registered office at 27 Wybrzeże Wyspiańskiego, 50-370 Wrocław (NIP 8960005851, REGON 000001614) - who owns the Website, working by means of organizational units of the Universities organizing Workshops.

The Administrator of Personal Data - Wroclaw University of Science and Technology- having its registered office at 27 Wybrzeże Wyspiańskiego, 50-370 Wrocław.

The Internet Service - the website of Workshop, through which it is possible to submit Orders and purchase Workshop services, which is owned by Wroclaw University of Science and Technology (the Organizer)

Co-organizer - Łukasiewicz Research Network - PORT Polish Center for Technology Development, Stabłowicka 147 Street, 54-066 Wrocław, Poland.

The Administrator of Personal Data - Łukasiewicz Research Network - PORT Polish Center for Technology Development - having its registered office at Stabłowicka 147 Street, 54-066 Wrocław, Poland.

The Order – Client's declaration of will expressing wish to purchase participation in the Workshop.

The Client - the ordering party, domestic or foreign person performing registration and purchase of participation in the Workshop.

The Workshop - a Workshop or other form of organized public meetings, including symposia, meetings, seminars, training, etc. presented on the Internet service, in which the Client can take part after purchasing participation via the Internet Service, or in the form of traditional bank transfer.

Autopay SA - Autopay S.A. with its registered office in Sopot at ul. Powstańców Warszawy 6, registered in the District Court Gdańsk-Północ in Gdańsk, VIII Commercial Division of the National Court Register under the number 0000320590, with a share capital of PLN 2,205,500 (paid in full), NIP 5851351185, entered into the register of payment service providers under the number IP17/ 2013.

The Payment Service - a tool provided by Autopay SA, allowing payments for purchases made on the Internet Service.

Manner and terms of Orders. Conclusion of the agreement. Order cancellation.

- 1. The Internet Service allows Clients to place Orders and to make the purchase of participation in Workshops.
- 2. The Client placing an order for Workshop services, offered in the Internet service, is required to fill out an application, select the offered package of services and to choose the form of payment. In case an invoice is required, the Client obligatorily gives all the necessary information which are required to write the invoice.
- 3. Before the payment, the Client accepts the "The Regulations of charging by electronic means".
- 4. The Organizer bears no responsibility if the Client supplies false or misleading information, if the Client cannot use the Internet Service or any part thereof as a result of using wrong browser, incorrect configuration of software or hardware, and does not warrant that the use of the Service will be possible using the full range of each hardware and software configuration.
- 5. After placing the Order, the Client receives an e-mail confirming Order placement, together with the selected package and the price and the method of payment. Upon sending the confirmation message, it is considered that the agreement between the Client and the Organizer was concluded.
- 6. The Client can change or cancel the placed Order only until its approval. Changing or cancelling Orders which were already sent, requires notifying the Organizer in the manner specified by the Organizer in Internet Service of the Workshop.

Article 3

Prices. Payments.

- 1. The Prices of Workshop services are presented in the Internet service of the Workshop. The Prices are given in EUR.
- 2. Upon receipt of the confirmation referred to in Article 2 Paragraph 5, the Client is obligated to make payments in the chosen form, as indicated in the Order's confirmation.
- 3. The Client can make a payment for Workshop participation in the form of a traditional transfer directly to the Organizer's account or in the form indicated below:
 - credit card via the Payment service if the Client is a foreign Client or a national one deciding to make the payment by a credit card.
- 4. Available payment methods. Credit cards:
 - Visa
 - Visa Electron
 - Mastercard

 - Maestro
- 5. Upon receipt of the payment, the Organizer issues an invoice on the request of the Client. The condition of receiving it is to provide the Organizer with all the necessary data.

Complaints and refunds

- 1. The principles of charging, the amounts, and payment deadlines, as well as the principles for refunds are provided by the Organizer in the Internet Service of the Workshop.
- 2. A participant may withdraw from the Workshop in terms and on the principles defined by the Organizer in the Internet Service of the Workshop.
- 3. Statements of resignation from the participation in the Workshop are reported to the Organizer by email to the address given in the Internet Service of the Workshop.
- 4. In case of the Client's resignation from the participation in the Workshop, the Organizer shall refund the received payment in the amount, time and on the principles referred to in Article 4 Paragraph 1.
- 5. Requests and complaints are dealt with within 14 working days from the date of receipt by the Organizer.
- 6. The Organizer shall make a refund within 21 working days from the date of receipt of the Client's resignation from the participation in the Workshop, subject to the rules referred to in Article 4 Paragraph 1.
- 7. The seller refunds the payment using the same method of payment as used by the consumer, unless the consumer has expressly agreed to a different method of return, which does not involve any costs for consumer.

Article 5

The functioning of the Internet Service.

- The Organizer makes every effort to ensure that the Internet Service works without any problems. However, due to essential maintenance and modernization there may be short disruptions in operation. The Organizer shall inform on the website of the Internet Service about the planned time and duration of such activities.
- The Organizer reserves the right to block access to the Internet Service for users suspected of manipulating or trying to manipulate its content by actions threatening the used software or aimed at its destabilization, or those who violate the provisions of these Regulations in any way.

Article 6

The technical requirements concerning the Workshop participant (payer)

- 1. Possession of an active email account.
- 2. Using the current version of the browser Microsoft Internet Explorer (Edge), Mozilla Firefox, Google Chrome or Safari, with JavaScript and cookies.

Personal data protection

- 1. In case of any doubts, it is assumed that the person whom the data concerns (specified while placing the Order) by entering their personal data necessary to complete the payment by means of the Payment Service and implementing the service referred to in these Regulations, gives consent to the processing of their personal data for the purposes and within the limits referred to in these Regulations. The Client giving personal data of a Workshop participant (if the data concern other person than the Client) is responsible for fulfilling the legal obligation to inform the person in question.
- 2. The Administrator of Personal Data assures processing of personal data obtained in connection with the services specified in the Regulations pursuant to the provisions of the Act of August 29, 1997 Personal Data Protection (Journal of Law of 2016 Item 922). The legal basis for data processing in this field are the art. 17 and 18 of the Act of 18 July 2002 on electronic services (Journal of Law of 2016 Item 1030).
- 3. The personal data that relate to the user of the Payment Service, given in the course of the transaction, shall be processed by the Organizer having its registered office on 27 Wybrzeże Wyspiańskiego in Wrocław. The address of data administrator the Organizer, is also its contact address.
- 4. The personal data is collected and processed in order to support the process of settlement of receivables from the person taking part in the Workshop.
- 5. In order to provide the service, the Organizer can process the data, including:
 - a) a surname and the names of the recipient;
 - b) personal identification number PESEL or (when this number was not given) the number of passport, identity card or other data adequately identifying the holder of an appropriate document confirming their identity;
 - c) the address of permanent residence;
 - d) mailing address, if it is different from the permanent residence address;
 - e) the data used to verify the qualified electronic signature of the recipient;
 - f) electronic addresses of the recipient;
- 6. In order to provide electronic services the Organizer may also process:
 - a) information that uniquely identify a subject of rights or a legal entity making the payment by means of the Payment Service;
 - b) other data necessary due to the properties of the service or a method of its settlement.
 - c) other data, which:
 - are necessary to issue an invoice;
 - are admitted for processing on the basis of separate laws or on the basis of an agreement concluded with the Client or a participant in the Workshop;
 - aim at providing the Client with the service including solving technical problems and providing access to functions;

- are necessary to contact the Client, including the purposes related to the provision of services and the Client's service;
- are enforcing compliance with these Regulations, including counteracting fraud and abuse.
- 7. A person, to whom the data relate to, expressing a voluntary consent for using the services provided by electronic means, simultaneously agrees that the Organizer and the entities acting on its behalf in connection with claiming due payments for the service which this Regulations concern, could process the data including also those which are not necessary for the provision of electronic services provided that they:
 - a) are necessary for the settlement of services and claiming due payments for the use of the service or to explain the circumstances of unauthorized use of the service;
 - b) aim to conduct analyses in order to improve the quality of Organizer's services, adapting the Organizer's offer to the Client's needs or are necessary for the implementation of permitted marketing activities, market research, and research on consumer market behavior and preferences that aim at improving the quality of Organizer's services, with the consent of the Client and by means of communication channels available to the Organizer;
 - c) necessary for the implementation of the agreements concluded in the framework of the activities carried out by the Organizer only in the range of the data obtained in connection with the Order.
- 8. The person to whom the data relate, provides them to the Personal Data Administrator for the period necessary to use the Organizer's service that these Regulations relate to and to settle the dues.
- 9. A person to whom the personal data refer is entitled, in particular, to access their data, as well as correct and change them.;
- 10. Providing personal data by a person to whom the personal data refer to, is voluntary and at the same time necessary for the transaction, and the lack of consent for processing shall result in the inability to use the services to which these Regulations apply.

Other provisions

- 1. Using the services of the Internet Service is equivalent to agreeing to all the terms and the information contained herein.
- 2. The Client is solely responsible for the accuracy and correctness of the submitted information.
- 3. The Organizer reserves the right to change these Regulations. If there are any amendments to the Regulations, the Organizer shall inform about them on the Internet Service. In that case, changes in the Regulations come into force on the date of their publication on the website of the Internet Service and have no retroactive effect.
- 4. In matters not regulated by these Regulations, the provisions of Polish law, including the Civil Code, shall apply.
